## T4T Services, Fees & Membership

T4T membership begins upon payment of dues, which are paid every 12 months for the duration of membership. Membership dues are on a sliding scale, based on operating budget reported on IRS form 990. Basic membership dues cover only one site; an additional fee will be applied per site for organizations wishing to receive T4T services at multiple sites. United Way member agencies receive a 20% discount on membership dues. Member agencies are those organizations receiving funding and support annually from UWSEPA or another local United Way.
